

Agreement for receiving a scholarship from a non-Technion source

I hereby declare that I have read the Attached agreement for a scholarship from a non-Technion source - ______, (hereinafter: "The Agreement with the Non-Technion Source"ⁱⁱ) declare and undertake as follows:

- 1. I am aware that within the agreement with the non-Technion source, the Technion contacted ______, stated and/or undertook various obligations regarding the receipt of the above scholarship from the non-Technion source.
- 2. I declare that the terms for the receipt of the Scholarship and the denial of the Scholarship specified in the Agreement with the Non-Technion Source have been brought to my attention, I accept them and agree to act in accordance with them.
- 3. Notwithstanding the provisions of the "Scholarship Receipt Agreement", which I signed with the Technion, I hereby declare and undertake that, to the extent required by the non-Technion funding source, the Technion may be required to return the scholarship money and/or tuition, in whole or in part, transferred to the Technion in my name and paid to me and/or transferred directly to me, I will act as instructed by the Technion and/or the funding source and return the scholarship money and/or tuition. I received from the non-Technion source (through the Technion and/or directly to the funding body), in full or in part, in accordance with the terms and requirements of the non-Technion financing source.
- 4. I am aware that my eligibility to receive the scholarship from the aforementioned non-Technion source may be implemented on the timeline set by the entity, and that the granting of the funds is subject to my eligibility for a Technion scholarship during this period. I acknowledge and am aware of the provisions of section 9 of the "Scholarship Agreement", according to which receiving "additional scholarships" (and in our case a scholarship from a non-Technion source), may lead to a reduction in the number of scholarships portions awarded by the academic unit, all in accordance with section 9 of the "Scholarship Agreement".
